EXAM OVERVIEW

To be able to register for the **NG1/NGC1** Open Book exam with Cambridge Safety you must have studied with us (classroom/distance learning/E-learning) unless your course provider has ceased to operate.

To enter for any Neboosh exam or assessment, exam registrations must be made by the time frame given on our exam timetable, to enable us to register you with Neboosh.

QUALIFICATION OVERVIEW

Nebosh General Certificate in Occupational Safety and Health 2020 Syllabus

This qualification consists of eleven course elements, four covering the management of health and safety and seven covering specific workplace hazards and risks.

The four management elements are assessed by one new style open book examination (NG1) accessed online at home, and the more practical hazards and risks are assessed via a comprehensive workplace risk assessment report (NG2).

Both exam and risk assessment have to be passed in a five year period to achieve the qualification. We recommend allowing approximately 100 hours of study time.

If you have taken the 2014 version of the General Certificate and have already taken one or more assessments - contact us as you will still be able to take the remaining exams in 2020 and 2021. If you still need to take the NGC1—this will now be in the form of an open book examination which you can take in a safe and secure location of your choice.

QUALIFICATION OVERVIEW

Nebosh Construction Certificate

This qualification consists of the NGC1 covering the management of health and safety and NCC1 covering construction specific workplace hazards and risks.

The five management elements are assessed by one new style open book examination (NGC1) accessed online at home, the NCC1 is a 2 hour written exam invigilated at Cambridge Safety, and there is a practical site inspection and report (NCC2), to be submitted to Cambridge Safety.

Both exams and practical have to be passed in a five year period to achieve the qualification.

Those who have achieved the Nebosh General Certificate (2014 syllabus only) in H&S in the last five years are exempt from the NGC1 examination.

Nebosh Fire Safety and Risk Management Certificate

This qualification comprises of the NGC1(Management of H&S) which is assessed by an Open Book Exam accessed online at home, FC1 Fire Safety: a 2 hour written exam invigilated at Cambridge Safety, and the FC2 work based fire assessment project which must be completed in the student's workplace. Those who have completed the NGC1 as part of the General Certificate (2014 syllabus only) or Diploma A in the last five years are exempt from the H&S management section of this qualification.

Nebosh Diploma in Environmental Management

This qualification covers 12 elements, plus 3 elements for the NDEM2 assignment.

Assessment is via one 3 hour written invigilated examination held at Cambridge Safety where delegates have a choice of 5 from 8 questions, and a work based project which is based on the production of an environmental audit.

Nebosh National Diploma in Occupational Health & Safety

The course is structured around four units:-

- Managing Health & Safety (Unit A) - One three hour examination
- Hazardous Agents in the Workplace (Unit B) - One three hour examination
- The Workplace and Work Equipment (Unit C) - One three hour examination
- Workplace Based Assignment (Unit DNI) - This can be submitted in February, May, August or November of each year

DNI assignment

The DNI is a significant piece of work to demonstrate your work as a H&S practitioner, it is be submitted when you have taken all three diploma examinations. The report **must** contain evidence of research & reading beyond your course notes.

The report may be up to 12,000 words but there is no maximum word count apart from the executive summary which must be on just one sheet of A4 paper. Nebosh suggest 8,000 words but past experience shows this may not be enough to enable all key issues to be covered in sufficient depth. However it is important that the report is not excessively wordy and therefore does not focus on the specific issues required.

As there is no word count limit you may place any material which you have actually completed in to the report, i.e. sample risk assessment forms, questionnaires etc. You should put any non original material that you have referred to in the appendix, i.e. copy of an extract of a company procedure. However only put into the appendix information that you actually refer to in the report and that which adds to the understanding of the report. Full copies of paperwork such as company H&S policies or HSE guidance notes are not required.
