

## NEBOSH INCIDENT INVESTIGATION



This new award level qualification is a one day course aimed at managers, supervisors, SHE champions, union representatives and aspiring health and safety practitioners.

It is designed for those new to accident investigation and those who are already undertaking investigations.

### Aims

The course is designed to provide the information to enable delegates to carry out investigations, identify immediate and underlying causes and write a meaningful report thus enabling actions to be taken to prevent a reoccurrence.

Students will be able to understand:

- accident/incident terminology;
- why accidents need to be investigated;
- how human and organisational factors can contribute to an accident;
- the accident investigation process;
- what good interviewing technique looks like;
- how to develop an action plan following an accident investigation.

## NEBOSH INCIDENT INVESTIGATION

There are no pre entry requirements for this qualification which is aimed at those undertaking accident investigations.

As well as tackling the extensive syllabus and standards set by Nebosh, the course will also give assistance in the preparation of the end of course assessment. The assessment takes up to 60 minutes and its format is unique to a Nebosh qualification with delegates competing the following three staged assessment:

- Watch three interviews about the accident
- Review the evidence
- Identify root and immediate causes and develop an action plan

Students who achieve this qualification will be able to: carry out a solo accident investigation of non-complex accidents and incidents including: the gathering of evidence, the analysis of that evidence. It will explore the development of a risk control plan; and to contribute to team accident/incident investigations for large-scale investigations.

Accident investigation is an important management tool, crucial for prevention, learning and/or dealing with insurance, litigation and the implementation of statute law.

Unplanned and unstructured interviews can result in critical information not being captured; loss of confidence in the investigation team due to the inability to capture sensitive information.

The course provides an excellent opportunity to identify both good and poor interview techniques and how these can influence the effectiveness of the investigation undertaken.
