

NEBOSH H&S MGT CONSTRUCTION

The NEBOSH Health and Safety Management for Construction Certificate is aimed at Supervisors, Managers, Estates and Facilities managers, all those involved in the selection of contractors, as well as construction managers. The course is aimed at those within the construction industry who are required to ensure that activities under their control are undertaken safely. It is likely to prove useful for those concerned with the management of buildings who may need to ensure that contractors are working safely.

The qualification is also appropriate for supervisors and managers working in other industries and work functions such as facilities and estates management. The course is now assessed via one online open book examination (**OBE**) over **2 days** covering construction specific issues. This course is particularly important as it enables organisations to meet their obligations under the Approved Code of Practice which forms part of the Construction, Design and Management Regulations 2015. It can assist in demonstrating competence to undertake the role of the Client, Principle Designer, Principle Contractor, Contractor or Designer.

The first three elements cover management of health and safety based around CDM 2015, and the other ten units cover the range of construction hazards with control measures

The course is run on a day release basis to suit the needs of both student and employer. The course is highly participative with tutor presentations supported by the use of practical exercises, syndicate and group work, films & videos plus tutor feedback sessions. Our **pass rates on all our Nebosh programmes** consistently exceed the national average.

Delegates are expected to complete revision questions and exercises outside the tutorials.

As well as tackling the extensive syllabus and standards set by Nebosh, the course will also give assistance and practical guidance on the end assessment.

After completing the qualifications delegates will be able to:

- advise on duties and manage construction risks under the Construction (Design and Management) Regulations 2015;
- justify the need for health and safety improvements;
- produce or contribute to a construction phase plan;
- help their organisation to manage contractors;
- positively influence health and safety culture and behaviour;
- carry out a risk assessment of a construction site and manage a range of construction hazards;
- recognise workplace changes and their impacts and understand how to minimise these impacts;
- develop basic safe systems of work that include emergency arrangements and know when to use a permit-to-work system; and take part in incident investigations.

NEBOSH H&S CONSTRUCTION

The course covers a broad range of construction hazards and the means by which they can be controlled. It includes the main legal requirements relating to construction work and enables students to undertake effective safety inspections on a construction site.

This NVQ level 3 qualification meets the academic requirements for Associate membership (AIIRSM) of the International Institute of Risk and Safety Management.

CSCS Cards

Following updates to the CSCS Academically Qualified Person (AQP) card scheme criteria, the NEBOSH Health and Safety Management for Construction (UK) qualification can be used as evidence of a relevant H&S qualification.

Training Venue

All courses are run in our training centre at Swan Court, Hampton, Peterborough. Which is easily accessed via the A47 and parkway system. Ample car parking is available on site and near by. The train station is less than 10 minutes away via car and there is a regular local bus service.

Course fees

£1600 + vat plus £182 Nebosh fees.

Bookings

It is a condition of booking that the fee is payable in advance. An invoice will be raised as required. Full joining instructions will be sent to delegates approximately 2 weeks before the course commences.

Cancellations

Cancellations must be made in writing and are subject to the following charges: £50 admin fee per booking; plus if 8 - 28 days notice are given 50% of the course fees and any exam fees pre-paid to Nebosh; No refunds will be made within 1 week of the course start date but you may send a substitute delegate provided their application can be accepted by the tutor and there is still time to register with NEBOSH for the examination. Once a course has started no refunds or substitutions are possible.
